1. PRODUCT DESCRIPTION :

POLYREY HPL FR M1

High pressure laminate obtained by stacking of Kraft paper impregnated with phenolic resin with fillers (from 30% to 40%), decorative paper - plain or printed - and overlay impregnated with melamine resin with fillers (from 75% to 80 %).

Treatment: phosphate mineral flame retardant treatment (in the mass)

Thickness : 0.8 mm to 1.2 mm

Mass: 1420 Kg/m³

The specimen has been tested on calcium silicate board (10 mm thick, density 950 kg/m³).

Adhesive used for the test : polyvinyl acetate glue, ref. "PLY-LOK 3050" from National Stark (100 to 130 g/m²).

4. APPLICATION / LIMITATION :

4.1 - Acceptable for use on any non-combustible and non-metallic substrate (complying with the requirements of MED 96/98/EC as amended) having :

- a minimum density of at least 713 kg/m³, with a thickness of at least 10 mm.

4.2 - In addition, the specimen tests results are showing compliance with FTP Code Annex 1 part 2 for smoke & toxicity requirements.

4.3 - Calorific value to be less than 45 MJ/m² as per ISO 1716 (2010), where required.

4.4 - The fitting aboard shall be the same as used for the test.

5. PRODUCTION SURVEY REQUIREMENTS :

This certificate alone does not allow the applicant to issue the Declaration of Conformity and to affix the mark of conformity (wheelmark) to the products corresponding to this type. To this end, the production-control phase module D "Production Quality Assurance" or E "Product Quality Assurance" or F "Product Verification" of Annex B of the Directive is to be complied with and controlled by a written inspection agreement with a Notified Body.
